Please refer to PESO's letter of even No. dated 15th February, 2017 intimating the launch of online "Licensing System for District Authorities (LSDA)" for the use of all the District Authorities for granting licenses under Explosives Rules, 2008 (ER) & Ammonium Nitrate Rules, 2012(ANR) w.e.f. 15th February 2017.

All the existing licences under ER, 2008 & ANR, 2012 holding manual licences issued by the District Authority are required to be re-issued (Back log Entry) through LSDA by the respective District Authority on or before 30th April, 2017, as communicated vide PESO's letter under reference.

In view of the difficulties expressed by the said license holders, as well as time required by the District Authorities to get acquainted with the "Licensing System for District Authorities (LSDA)" module, the cut-off date for re-issue (Back log Entry) of such manual licences has been extended from 30th April, 2017 to 14th July, 2017.

From 15th July, 2017, those licenses which are issued by District Authorities through the online "Licensing System for District Authorities (LSDA)" will only be enabled to carry out online transactions such as raising online indents, purchase, sale, transport & use of

- Explosives through PESO's online "Explosives Return System (ERS)"
- Ammonium Nitrate through PESO's online "Ammonium Nitrate Return System (ANRS)"

All License Holders under ER, 2008 & ANR, 2012 granted by PESO are requested to make a note of it and to advise to inform all the DM's license holders to whom they are supplying Explosives/Ammonium Nitrate; to approach the respective District Authority with following documents to get their manual license re-issued (Backlog Entry) through on line system (LSDA), prior to 14th July, 2017.

- a) Filled and signed <u>INPUT FORM (Explosives)</u> or <u>INPUT FORM (Ammonium Nitrate)</u> available in the login page of ERS & ANRS.
- b) Original copy of manually issued DM's license for surrender to DM's Office.
- c) Five copies of color photographs of the Occupier signed by him on the face of the photographs for affixing on the online granted license.
